## Walking Field Trial - March 14, 2010

The club's Walking Field Trail will be held on March 14 near Hillsboro, IA. If you've never been to a Walking Field Trial, please feel free to come and watch. An AKC Walking Field Trial is a field trial where ALL contestants must handle their dogs while walking on foot. The judges and spectators may ride horses but not the handlers themselves. The dogs are judged on their potential in the field under similar conditions.

The stakes or classes are divided two ways, by age or by style of hunting. The age groups are puppy, derby, and adult stakes. The styles are gundog and all-age. In the puppy class the age is limited from six to fifteen months old. The derby is for dogs six months to two years and the adult classes are for dogs six months and older. In the style-differentiated classes a gundog is expected to quarter and handle for a foot handler or hunter whereas the all-age is a more independent dog that tends to run further to the front and think and act more by itself than a gundog. For this reason allage classes are usually not offered at walking trials

In an online AKC article titled, <u>Walking Field Trials Attract New Participants</u>, Dennis Pierce states:

"I cannot state strongly enough that the AKC walking trials must be a big part of field trials. If we want to continue to attract new trialers, and to sustain the sport, with increasing land prices and horse costs, the AKC walking formats allow for learning about the sport, or finishing a FC dog without a lot of money being spent,"

There are three types of conformation dog shows. Specialty shows are restricted to dogs of a specific breed which means you'll see only Brittanys at our show! A judge examines the dogs, then gives awards according to how closely each dog compares to the judge's mental image of the "perfect" dog described in the Brittany's official standard. ## Field Trial - April 2-8, 2010

The club's Spring Field Trial will be held April 2-8 at Union County Bird Dog Ranch, two miles south and one mile west of Thayer, Iowa. This is a Pointing Breed Trial open only to Brittanys. Field Trials offer practical demonstrations of a dog's ability to perform the functions for which it was bred. In Field Trials, the dogs compete against each other for placements and points toward their championships. Dogs can earn an FC (Field Champion) title in front of their names on AKC records. The Iowa Brittany club will be holding an AKC Pointing Breed Hunt Test tentatively scheduled for April 24-25, pending AKC approval. The hunt test will be held at the Steelclay Shooting Sports, LLC in Eddyville, Iowa. This event is open to all AKC pointing dogs.

The AKC Hunt Test program provides an opportunity for a dog to demonstrate its field abilities in a manner consistent with the demands of actual hunting conditions. It is also an excellent opportunity to keep you dog sharp and physically fit between hunting seasons. There are 3 levels of testing: Junior Hunter, Senior Hunter and Master Hunter.

# **Eligibility Requirements to Hold Future Dog Shows**

- Every club applying to hold a show must host at least <u>one major activity</u> within the calendar year to be approved for the next calendar year's show(s)
- ⇒ Each club is also required to conduct and document at least <u>two additional activities</u> within the calendar year to be approved for the next calendar year's show(s).

As a club, we can view these requirements as an extra burden or as an opportunity. This year, let's look at these requirements as an opportunity to raise awareness about the lowa Brittany Club and the activities a Brittany can do! Marcy Beveridge has volunteered to be our "compliance coordinator" to be sure we meet the requirements in 2010 so we can hold our specialty show in 2011. From July 1, 2009 to December 31, 2009, American Brittany Rescue (ABR) volunteers helped 43 dogs in Iowa. During that six-month period, 30 of those dogs were adopted and on January 1, 2010, 15 were still in foster care. Currently, the average time a Brittany remains in foster care in Iowa is 35 days. Iowa currently has 33 ABR volunteers.
