## **Camping:**

The Henry County Conservation Commission has camping spaces available at the Oakland Mills Access area. This area is located about 4 miles north of Salem on County W-55. For information call the Conservation Commission at (319) 986-5067.

## **Food:**

There will be no food served at the trial. Salem has Sharon's Country Place and Kramer's Gas and Groceries in which food and supplies may be secured and Salem is about 4 mile east.

## **Horses:**

No horses will be provided by the club.

## **Directions:**

Take U.S. 218 south of Mt. Pleasant to Highway 125(Salem Stub). A truck stop is located at the intersection. Turn west on Highway 125 for about 3 miles. Highway 125 curves past a school, but stay on 125 until you reach a stop sign. Continue straight through the intersection at the stop sign which will be the start of J-20. Go about 4.2 miles then turn right (north) on gravel road. The trial grounds are 3/4 mile down the road.

U.S. 34 west of Mt. Pleasant to W-55 south to Salem. Go about 8 miles then turn right (west) at the second stop sign onto J-20. Go about 4.2 miles then turn right (north) on the gravel road. The trial grounds are 3/4 mile down the road.
