The Iowa Brittany Club would like to welcome you to our AKC Licensed Hunting Test, held at the Earl Stout Farm, southeast of Rose Hill, Iowa (near Oskaloosa).

## Directions to the Grounds (see map on last page)

From Oskaloosa, east on Hwy 92 approximately 11 miles to Yarnell Street. Go south on Yarnell, to 235<sup>th</sup> Street. Go east on 235<sup>th</sup> Street to Yarnell Street. Go south on Yarnell to 260<sup>th</sup> Street. Go west on 260<sup>th</sup> Street to the Earl Stout Farm on the right side of the road. There will be signs posted at the corners indicating where turns are to be made starting at Hwy 92.

Note: We are proud to have private grounds on a dead-end road without highways or highly traveled roads nearby. The roads leading to and around the grounds area are low traffic gravel roads.

## Directions to Hunt Test Grounds

**Earl Stout Farm, Rose Hill, Iowa**  
(east of Oskaloosa)

**From the East:** From Hwy 149, go West on Hwy 92 about 15 miles to Yarnell Street.

**From the West:** From Oskaloosa, take Hwy 92 about 11 miles East to Yarnell Street.

- Turn South on Yarnell Street.
- Turn East on 235<sup>th</sup> Street for about ½ mile, then follow the curve to the South onto Yarnell Street (again).
- Follow Yarnell about another mile, to 260<sup>th</sup> Street, turn West.
- Go about ¼ mile, through the gate to the Hunt Test grounds on your right.

There will be signs saying "Iowa Brittany Club Event" at the corner of Hwy 92 and Yarnell Street and at each turn from there to the grounds.
